Minutes of the monthly meeting held on Tuesday February 3rd at Yr Hen Ysgol Eglwyswrw at 8 pm.

388 . CHAIRS OPENING COMMENTS

Apologies were received from Chair Cllr Sian Jones and Vice Chair Sion Morgan. In their absence Cllr Gareth Johnson agreed to chair and welcomed everyone to the meeting.

389. Minutes of the monthly meeting held on January 13th at Yr Hen Ysgol

After pre-circulation of the minutes and consideration of their accuracy, they were noted and signed as a correct record. Cllr Enid Cole proposed and Cllr Ieuan Davies seconded. It was a unanimous decision of all present.

390. DECLARATION OF INTERESTS -

None declared.

391. MATTERS ARISING DECISIONS AND ACTIONS

- Pothole Update – Cty Cllr John Davies recapped upon his previous report noting that some of the potholes did not meet the dimensions identified by the council as requiring remedial action. The effect of gritting and snow ploughs during the winter months can cause a deterioration which will need to be monitored.
- Cllr Arwel Evans confirmed that the new pads for the defibrillators have been ordered and paid for by him. Cllr Ieuan Davies proposed that the Clerk should provide a cheque to reimburse the cost of £211-20 as per the invoice supplied. Cllr Ieuan Davies seconded and all were in agreement. Action – Clerk to provide a cheque to reimburse Cllr Arwel Evans.
- Grit Bins Update – Cty Cllr John Davies has arranged delivery of three new grit bins , two have yet to be located. They are heavy duty bins and should prove very resilient. Cty Cllr Davies has paid for the bins to avoid delay. Cllr Lon Davies proposed that he be reimbursed by ECC and Cllr Enid Cole seconded. All present were in agreement. Action – Clerk to arrange for a cheque to cover the cost of the bins.
- Cllr Enid Cole reminded members of the decision made in 2025 to make an additional donation from ECC in support of Eisteddfod y Garreg Lâs in 2026. The sum decided and minuted in a previous meeting was £1850. Cllr Cole proposed that this sum should be made forthwith and Cllr Ieuan Davies seconded. All were in agreement – Action Clerk to provide a cheque as soon as possible to cover the donation.
